Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Sealed or electronic bids must be submitted to the office Secretariat of state assembly by hand/courier or through PPMO website www.bolpatra.gov.np/egp on or before 12:00 o'clock on **26 February 2020**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 o'clock** on **27 February 2020** at the office of Secretariat of state assembly, Butwal. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs 1,20,000.00, cash deposit in Account No.: **3120 5020 00000**, Rastriya Banijya Bank, Butwal Branch, Rupandehi in the Account holder name of Pradesh Lekha Niyantarak karyalaya, butwal for Pradesh sabha saciwalaya Office Code no. : 2020048015 or in the form of unconditional Bank guarantee from a bank guarantee from Commercial Bank or Financial Institution eligible to issue Bank Guarantee as per prevailing Law, in the name of Secretariat of state assembly, Butwal which shall be valid for 30 days beyond the validity period of the bid
