3. Completed filled Bid document with necessary supporting documents must be submitted to the office of Secretariat of Provincial Assembly, Rupandehi, Nepal on or before 12:00 of 31st day from the date of first notice published. Documents received after this deadline shall not be accepted.
4. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 31<sup>st</sup> day from the date of publication at 14:00 hours at the office of Secretariat of Provincial Assembly, Rupandehi, Nepal.
5. Bids must be valid for a period of 90 *days* counting from the day of bid opening and must be accompanied by bid security of minimum amount as specified in above table, cash deposit in Account No.: 3120 2020 00001, Rastriya Banijya Bank, Butwal Branch, Rupandehi or in the form of unconditional Bank guarantee from A class Bank in favor of Secretariat of Provincial Assembly, Rupandehi, Nepal which shall be *valid for minimum 30 days* beyond the bid validity period.
6. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
7. The employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
8. Other terms and conditions will be in accordance with the Procurement Act, 2063, Procurement Regulation, 2064 and the prevailing laws of Government of Nepal.
